In 2006, I found myself 27 weeks pregnant with an OB/gyn that did not leave me with much confidence at all, especially for a first time mom. I was referred to a new doctor by a good friend of mine. The new doctor was Dr. James Caputo of Syracuse, NY. On my first office visit, my husband and I were convinced that we made the right decision by switching providers. I was examined, sonogrammed and then we went into the doctor's office for a consultation. Dr. Caputo explained that I had an incompetent cervix and was too far along to have a cerclage. He explained to us at length and detail what that meant and we were impressed at how he stressed the seriousness without scaring us. Because my cervix was already dilated, he placed me on limited bed rest until my next appointment two weeks later. On my next appointment he showed us how I had progressed and needed immediate care and had me admitted into Crouse Hospital. To make a long story short, my son was born healthy at 36 weeks. I have no doubt that had I stayed with my previous OB/gyn, I most likely would have given birth on a trip scheduled (and ok'd by my previous OB/gyn) to Las Vegas which would have occurred during my 28 to 30 weeks gestation.

I tell you this story because I am dumbfounded by the egregious actions toward an obviously dedicated and highly skilled doctor and surgeon. Beside the fact that he may have saved the life of my son, he took unbelievably good care of me and my baby. He was always so patient and gentle. My husband came to each and every visit and Dr. Caputo took the time to make sure we both were comfortable with every decision. I trust him with my life and the life of my children.

In closing, I would like to mention that when Dr. Caputo was suspended and his practice was forced to close, I was 30 weeks pregnant with my second child. The news was devastating to us. The new doctor I was forced to see instead was no where near his caliber, yet I didn't have time to find someone else (not to mention time to become comfortable with them). So I had to see someone that was not familiar with me, my history, or my circumstance. The results were less than desirable to say the least. The new doctor could not remove the cerclage properly and had to admit me into the hospital. My water broke while in recovery and I gave birth while suffering from a spinal leak induced head ache. Even when Dr. Caputo could no longer see me as a patient, he made sure his replacement could contact him, giving us his home number and pager so that he could verbally assist in removing the uncommon type of cerclage he put in place. The new doctor did not feel it necessary to contact him which resulted in terrible pain and surgery. And as I recovered from this ordeal, spending many days (more than twice a normal stay) in the hospital, I missed the out of town visits from my family and much of the first three weeks of my newborn's life. I am certain that had Dr. Caputo continued to be my physician, none of this ordeal would have happened nor would he have allowed such careless consideration for a patient's pain. I am further disappointed and basically angry about the actions of malice and spite toward someone who gave so many the best possible care.

Dr. James Caputo was a wonderful and caring physician and our family has felt at a loss for his departure.

My family and I were devastated when Dr. Caputo's office was forced to close. Going to the doctor has never been one of my favorite things to do. When I found out that I was pregnant, I was scared to death. My husband and I had been married for 17 years and had given up hope of ever having a child. The mere fact that we were pregnant was surely a gift from God. The tricky part was to stay pregnant. Sitting in Dr. Caputo's office, meeting him for the first time gave us a minute to look around and "see" who he was. An obvious man of faith who is deeply devoted to his family, his quick smile and his vast knowledge of medicine made us feel confident that he would be able to help our family.

My preexisting health conditions were a serious cause for concern. Dr. Caputo was always forthright and honest about the complications and risks but also educated us along the way. He spent time with us, talked to us, sharing anecdotal stories and the science behind what was happening as our baby developed. He and his staff were always readily available to address my questions. In fact, I needed to take insulin during my pregnancy and during the initial dosing set up I would call in my glucose readings when I first woke up in the morning. I get up early- and so did Dr. Caputo to return my call and give instructions...7 days a week.

All things considered, my pregnancy went well and we delivered a healthy 10lb., 13 oz. baby boy two days after Christmas via cesarean section. Our trust in Dr. Caputo and his abilities was reassuring and comforted us greatly. The idea of surgery didn't scare me at all as Dr. Caputo had walked us through the procedure prior to the delivery day.

My stay at Crouse Hospital was a NIGHTMARE. While the nursing care was very good, the policies that the hospital prints in all of their brochures about their maternity ward are for show only. The floor was to capacity and I ended up with two different roommates that essentially had parties in the room with 15+ persons at the bedsides. No one at the hospital cared to enforce any sort of rules. Only when a guest of my roommate threatened my husband with hot coffee (he had asked them to quiet down a little) did the head of the nursing staff move us to a quiet room. I really just wanted to go home and was preparing to do just that. This commotion elicited 3 phone calls to Dr. Caputo who was visiting family in Rochester- he immediately returned from Rochester to see my husband and me. His presence brought calm.

Since the closing of his office, I have seen another doctor that came highly recommended by my friends and even Dr. Caputo himself. While my new doctor is certainly experienced, he's just a doctor. His office is efficient, yet sterile, lacking personality. Having been to this new doctor, my husband and I have decided to not have any more children. The experience just wouldn't be the same.

I check Dr. Caputo's site on a regular basis hoping to see when and where he'll return to practicing medicine – I do hope it is soon. He is very devoted to his family; his practice was his extended family-he was devoted to us, his patients, too. He is an amazingly gifted man.

At 33 weeks, I suffered pre-eclampsia and had an emergency cesarean. After giving birth, the baby was low weight but healthy, thanks to God and Dr. Caputo. Dr. Caputo treated both me and my baby to ensure a successful delivery.

After surgery I kept losing blood, but Dr. Caputo worked diligently to save my life. I was in the critical care unit for two weeks and in the hospital for a total of three weeks. 

I was not comfortable with what he had told me seeing that I had never had a pap smear that was abnormal since I started being checked at the age of 17. Dysplasia of the cervix is a condition that is considered to be a precancerous condition. Left untreated, dysplasia sometimes progresses to an early form of cancer known as cervical carcinoma in situ, and eventually to invasive cervical cancer. The Dr. that I had previously had had advised me that surgery was not necessary, and come to find out this Dr. happens to be a name that Dr. Caputo has mentioned in this battle he has come to face. Learning this I was completely disgusted. Had I stayed with this Dr. I can only imagine what I would have encountered as I got older. I was so glad that my close friend referred me to him. My personal history may not be severe, but I totally and completely put all trust in this Dr. for these last 6-7 years. I believe him to be one of the best dr's that I have ever had and am deeply saddened by what is happening to this man. It's very hard to find a Dr who you can be comfortable with and feel like you can trust this person knowing that what he is telling you is correct, and also educating you in the process so that you understand everything that is being told to you. I had worked in a Dr's office myself for 9 years, and I have seen great care, but also bad care.

I am now at the age of 33, and am 31 weeks along in my 1st pregnancy and was devastated by the fact that I was forced to switch Dr's in the middle of my pregnancy. I was comfortable with this Dr. and being that this experience my first, nervous, not knowing what to expect, he had made me feel much better and at ease when I had asked questions in my last visits that I had with him. He had delivered my niece in January of 2007, and my mother could not say enough how truly wonderful he was with my sister. She felt that my sister was in great hands, and loved this Dr. as well.

The turmoil that this Dr. has been put thru, along with his family is truly horrible. I feel a great loss of this Dr. not only to myself but to our community as well.

Hi, My name is Michelle A I am writing to support Dr. Caputo. I am very sickened by all this. Why a good man and a great doctor is being punished and having his life taken away from him. These people that are doing this to him should be ashamed of themselves. How do they sleep at night? I have met a lot more doctors that deserve this but no way should Dr. Caputo go though this.

This is my story: I met Dr. Caputo in July 2003 after Dr. Chick could no longer help me. See since I met my husband in 1999 we were trying to conceive. I was seeing another doctor up until 2003 when I transferred to Dr. Chick he diagnosed me with PCOS but still couldn't help me. He said Dr. Caputo knew more. So I met him and he explained every thing to me with diagrams in his office and explained it in a way that I would understand (not with big words). He told me it would be a long process but to not give up hope. I and my husband went thru numerous tests and drugs. I tried every fertility drug there was then I was told I had to give myself shots. I had to go pick this prescription up and my insurance would not cover it, so I called Dr. Caputo's office and he called my insurance office and got them to approve this prescription. I have never seen a doctor go out of his way like that. Then finally this fertility drug worked and in Feb 2004 I was pregnant. I can't explain the feeling. It was the happiest moment of my life. Dr. Caputo was happy for us and explained everything what might happen and what I have to do.

In July 2004 Dr. Caputo pulled me out of work because of high blood pressure and told me to rest and enjoy my pregnancy but my disability insurance would not let me, so once again after talking with the disability insurance they approved me to stay home. Again what doctor does that for his patients?

Finally in October 2004 I had to be induced 3 weeks early for toxemia. I had to have an emergency c-section and I felt like I was going to die. My son was stuck in my pelvic region. Dr. Caputo knew exactly what he was doing never got nervous and even calmed me down with humor. He saved mine and my son's life that day. I never could have done it with another doctor.

Then in the hospital I became very weepy, he would come and check on me and sit on my bed and talk to me until I stopped crying. Afterward at home I had post partum depression really bad for about 6months. Then me and my husband were having some problems due to my depression and I had a follow up visit with Dr. Caputo and he looked at my and asked what was wrong. He was the first person I told my problems to about what was going on. Once again what doctor do you feel you can talk to and trust?

To this day I feel Dr. Caputo has saved my life in a different way. I am very depressed cause since this I and my husband have separated. Sometimes I find it hard to get out of bed but I have my miracle who is now almost 4. My son is what keeps me going and if I never met Dr. Caputo and all the stuff I just explained to what he did for me I would never have my son today. He always went out of his way to help me and it sounds like he did the same for others. I am having some more problems associated with my PCOS and I wish Dr. Caputo could be helping me, because I'm scared right now and I know he would calm me down and help me. His staff was also excellent too.

I am writing this to give my complete support to Dr. Caputo. This man has been a Godsend to my husband and I. In 2002 while pregnant with our first child I was rushed to Crouse from New Hartford in preterm labor at 31 weeks. Dr. Caputo who is a friend of my brother-in-law and came to check on us at the hospital, up until that day I had never even met him. He came every single day even though I was not under his care. Then four weeks later, after being discharged and released back to my original doctor in New Hartford, I gave birth to our daughter. During her birth my obgyn at the time used forceps incorrectly thereby causing such severe brain damage and loss of blood that she was

kept alive on a ventilator. Again, still not as my doctor, he came to visit us every single day of the five days she was with us. Upon our discharge we were given all of his contact information should we need him. Shortly thereafter I made one of the best decisions I ever have, to become his patient. The time that followed brought a miscarriage at 10 weeks. I cannot say how much his compassion helped get us through that. Had we gone to any other doctor I don't think we would of faired nearly as well as we did. He performed my D&C during his only available time - his lunch. He sent over a nurse (who also happened to be the nurse who discharged me after our daughter died) to be with us while we waited to go in. He held our hand through the months of trying both before our miscarriage and after until we conceived our son. That pregnancy was an emotional rollercoaster for us. There is no other doctor that would of been nearly as compassionate, understanding or supportive of us. He kept our son safely inside me for my entire pregnancy and was always available to us. There are no words to properly thank him for bringing our son into this world and helping to heal our hearts. He has been there for us every step of the way over the past 6 years. There is absolutely no other doctor I want to deliver our children. I can't even get into the emotions we have over the fact that one of the cases against Dr. Caputo involves a forceps delivery in which those forceps did no harm to the baby when the doctor who killed our daughter still practices. Dr. Caputo has known me since I was 13 years old. He became my mother's doctor in 2000 after she left a doctor that caused her to lose a child in 1998. Due to my mother's age and health she was labeled as high risk. With her being on close watch, we practically lived in his office. I attended all appointments with my mother. Through that process, Dr. Caputo did everything to keep us informed about what was going on. He broke down information so that I could even understand. He spoke to me about being a pediatrician (what I wanted to become at that time). He didn't mind the thousand questions that I always asked. He was very welcoming. At of my mother's normal check ups we found out that she had developed a severe case of pre-eclampsia. Her blood pressure was so high that he was surprised that she was even able to stand. He wanted her rushed to the hospital via ambulance. She refused because she felt that she was fine. When we got to the hospital, Dr. Caputo was there ready and waiting. Long story short, my baby brother was delivered by c-section with no complications or health risks. But even though the baby was now safe, it didn't mean that my mother was. Her body was swollen to about three times her normal size. She started getting bed sores (not because of anything to do with Dr. Caputo, but because of the lack of care from the nurses). She even began to hallucinate. I even had to sit and watch my mom practically lose her life. Due to the wonderful care of Dr. Caputo, I still felt comfortable through this whole ordeal. Finally after four weeks my mom was allowed to come home. She is now known as the "Queen of Pre-eclampsia", because he has never seen a case as bad as hers.

This was not the only time Dr. Caputo saved my mother's life. My mom was in the hospital for severe pain and shortness of breath. The doctor whose care she was under at the time had not yet told us what was going on. Dr. Caputo came into my mom's room just because he noticed her name while he was

doing his rounds. After hearing what was going on, he gave her the instrument used to help you breath deeper. (please excuse my lack of terminology) We later found out that she had blood clots in her renal vein and also in her lung. We were told that her lung did collapse and that the only thing that kept her breathing and all of her tissues getting oxygen was the breathing apparatus given to her by Dr. Caputo. I owe my mother's life to Dr. Caputo. That's not all I owe him.

I have endometriosis and polycystic ovarian disease. In 2006, I became extremely ill. I would vomit anything I ingested. I became very weak and pale from the lack of nourishment. Once I noticed this was not just some stomach bug I went to the ER. They found a dermoid cyst on my right ovary. At my follow up appointment with Dr. Caputo, he instructed me that we would have to do surgery to remove it. He also stated that he was surprised that my ovary had not twisted due to the size of the cyst. The cyst was the size of a grapefruit. He also told me that my chances of being able to save the ovary was very slim. This was a great concern for me. After waking up from my surgery, Dr. Caputo came in to tell me how everything went. He asked me was I having pain in my right side. I told him yes but my primary doctor couldn't figure out why. He told me that there was scar tissue underneath my ribs. He said he was able to remove it during the surgery. Then he told me that he was able to save my ovary. I was so happy. He was able to go in, remove scar tissue, remove my cyst and keep my ovary.

I feel like I am indebted to Dr. Caputo. He saved my mother's life, managed to deliver my brother and my daughter (in perfect health), and I still have two ovaries.

Dr. Caputo was put in our lives by God. He is truly the guardian angel of our life.
